

**EVERYDAY COMPLEXION MEETS RED CARPET GLAMOUR: A CIELE COSMETICS MASTER CLASS WITH CELEBRITY MAKEUP ARTIST AND FOUNDER NIKKI DEROEST**  
**Official Rules**

**NO PURCHASE, POINT REDEMPTION, OR EVENT ATTENDANCE NECESSARY TO ENTER OR WIN**
